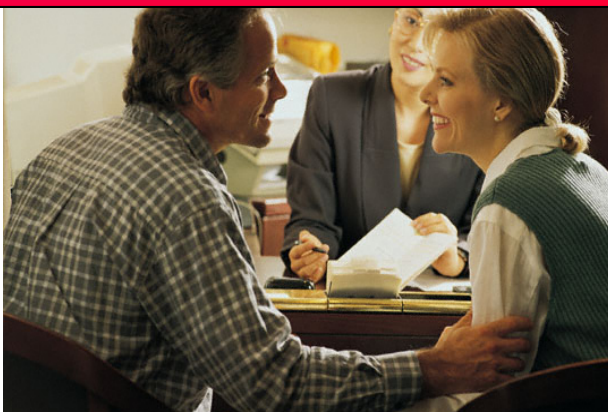

More Than One Way Out is an NFCC course that meets the needs of those who are seeking Pre-Filing Counseling that is mandated by the bankruptcy law. The material explores alternatives to bankruptcy, including discussions of the differences between a Chapter 7 and a Chapter 13 filing.



Live a Richer Life, also produced by the NFCC, is designed to satisfy the Pre-Discharge Education needs as mandated by bankruptcy law. The course provides information about managing personal finances, analyzing spending patterns, establishing a personal budget and consumer protection.
